Extension of Recognition upto elementary stage in favour of Holy Cross School, Pabiacherra, Kumarghat is hereby accorded provisionally for a period of 3(three) years commencing from 05/03/2024 to 31/03/2027 subject to fulfillment of following terms and conditions.

- 1. No grant-in-aid shall be provided to the school.
- 2. All un-trained teachers shall have to be trained with-in next 2 years.
- 3. Direction of the state Govt from time to time shall have to be complied with.
- 4. Adequate precautionary measures for fire extinguishment/ emergency exithave to be put in place.
- 5. Before imposing any fees a-new, the school authority must seek approval from the competent authority of the School Education Department.
- 6. The school authority shall issue appointment letters in favour of all staff working in the school indicating the relevant scale of pay along with other financial benefits.
- 7. Salaries & wages of teaching & non-teaching staff shall not in any way beless than the amount notified by Labour Department, Government of Tripura for private educational institutions from time to time.
- 8. The school management shall be under obligation to follow the Right of Children to Free & Compulsory Education Act, 2009.

- 7. The salaries or wages of teaching and non-teaching staff shall not in any way be less than that notified by the Labour Department, Government of Tripura for private educational institutions from time to time.
- 8. The school management shall be under obligation to follow the Right of Children to Free & Compulsory Education Act, 2009.
