Subject:- Extension of Recognition upto Upper Primary stage in favour of Holy Cross School, Pabiacherra, Kumarghat - permission regarding.

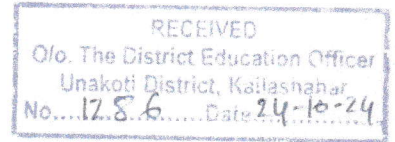
With reference to the application vide. Ref No.: REGELSCHOO/2024/00038 dated 05/03/2024 of the Holy Cross School, Pabiacherra, Kumarghat. Extension of Recognition upto elementary stage in favour of Holy Cross School, Pabiacherra, Kumarghat is hereby accorded provisionally for a period of 3(three) years commencing from 05/03/2024 to 31/03/2027 subject to fulfillment of following terms and conditions.

1. No grant-in-aid shall be provided to the school.
2. All un-trained teachers shall have to be trained with-in next 2 years.
3. Direction of the state Govt from time to time shall have to be complied with.
4. Adequate precautionary measures for fire extinguishment/ emergency exit have to be put in place.
5. Before imposing any fees a-new, the school authority must seek approval from the competent authority of the School Education Department.
6. The school authority shall issue appointment letters in favour of all staff working in the school indicating the relevant scale of pay along with other financial benefits.
7. Salaries & wages of teaching & non-teaching staff shall not in any way be less than the amount notified by Labour Department, Government of Tripura for private educational institutions from time to time.
8. The school management shall be under obligation to follow the Right of Children to Free & Compulsory Education Act, 2009.

7. The salaries or wages of teaching and non-teaching staff shall not in any way be less than that notified by the Labour Department, Government of Tripura for private educational institutions from time to time.
8. The school management shall be under obligation to follow the Right of Children to Free & Compulsory Education Act, 2009.
